








MACHINERY SECTOR

- It has the second rank after oil trade.









✓ Top three countries in global machinery trade CHINA, GERMANY and U.S.A in 2009.

- China, exports only 3 billion \$ machinery on 1992, in 2009 exports 236 billion \$ of machinery and now China is the leader machinery exporting country of the World.
- ✓ Germany, increased machinery exportation from 80 billion \$ in 1991 to 204 billion \$ in 2009.




















TURKISH MACHINERY SECTOR

• Machinery sector basic driving force of industrialization of Turkey.

 Share of leading countries in the machinery export of Turkey accounts 60 percent.

 Machinery export accounted for 8% in 2010, out of the total export volume of Turkey





TURKISH MACHINERY SECTOR

- Major partner of Turkey in machinery export is Germany.
- Ranked 29th in export and 27th in import in the World.
- It's the 6th biggest machinery producer of Europe and preferred for quality products by leading countries





TURKISH MACHINERY SECTOR

- Turkish machinery sector is able to meet the
- requirements of industry.
- Major export product groups in 2010 were;
- -Air conditioning units-cooling Machinery (14,5%),
- -Construction & Mining Machinery (11,7%),
- -Pumps & Compressors (9,2%)
- -Metal Working Machinery & Machine Tools (8,1%)
- -Machineries for Food Industry (7%)

- Invents and benefits from latest production methods and new technological developments,



TURKEY-IRAQ FOREIGN TRADE



- IRAQ is taking <u>5th place in Turkey's export</u> with USD 6 billion in 2010,
- and taking <u>30th place in import</u> with USD 1,3 billion in 2010.
- In 2010, Turkey ranked <u>1th</u> in IRAQ's import. TURKEY is the <u>leader partner</u> of IRAQ's foreign trade.

- Turkey's machinery export to Iraq was USD 416 million in 2010. Turkish machinery and accessories export to Iraq increased 78 % between 2007-2010.
- In 2010, Turkey's machinery export to Iraq increased 26% compared to 2009.







TURKEY - IRAQ

- Iraq was the <u>6th</u> country in Turkey's machinery export.
- Share of the Iraq was 4,4% in total machinery and accessories exports of Turkey in 2010.
- In 2010 main export groups to Iraq were; refrigerators, air conditionig machines, washing machies, valves, centrifuges and pumps.








- high rate of domestic input,

TURKEY

- Turkey is a member of G20 and has the booming economy.
- Her economic growth is sustainable (4.3 percent annual average real GDP increase for the last 7 years)
- It is expected to be the fastest growing economy among the OECD members during 2011-2017 with an annual average real GDP growth rate of 6.7 percent.







TURKEY

- Turkey is the 6th largest economy compared to the EU area in 2009.
- When studied the export composition of leading countries, approx. 20 % percent share of machinery export volume in total could be easily recognized.
- Turkey aims and committed to enter into developed countries league with high technology.









After world financial crisis, Turkish industry has an opportunity to prove itself.

Turkey will tend to place itself among top ten developed countries in the next decade.

Turkey is a good place to invest and Turkish machinery and accessories sector is a good partner to work with.

OBJECTIVE

- In 2023, Turkey is planning to reach USD 500 billions total export which entails USD 100 billions of machinery export. After global crisis, in the last quarter of 2009, many industries started to recover.
- In the year of 2010 machinery export of Turkey increased by 14% and reached USD 10 billions, justifying predictions for faster grow.
